Phase-XIII/2025 Selection Posts Examination (Matriculation Level posts) – Declaration of Result of Computer Based Examination for shortlisting candidates for next stage of scrutiny

Staff Selection Commission conducted Computer Based Examination for **Matriculation Level** posts under Phase-XIII/2025/Selection Posts Examination from 24.07.2025 to 02.08.2025 and 29.08.2025 at various centers all over the country. A total of 12,09,332 completed applications were received for Matriculation Level posts.

2. Representations received from candidates with regard to Tentative Answer Keys have been carefully examined and the Answer Keys have been suitably modified wherever necessary and finalized thereafter. The final answer keys have been used for evaluation of performance of candidates in the Examination. Final Answer Keys along with Question Papers cum Response Sheets of Computer Based Examination will be uploaded on the website of the Commission shortly.

3. Marks scored by the candidates have been normalized as mentioned in Para 15.3 of the Notice of the examination. Such normalized marks have been used for processing of results to shortlist the candidates for the next stage of scrutiny.

4. As per Para 19.7 of the Notice of the Examination, candidates scoring minimum qualifying marks in the computer based examination, as given below, have been considered eligible for shortlisting to the next stage of scrutiny:

(i)	UR	:	30% (i.e. 60 marks)
(ii)	OBC/EWS	:	25% (i.e. 50 marks)
(iii)	All other reserved categories	:	20% (i.e. 40 marks)

5. As per recruitment procedure mentioned at Para-19.8 of the Notice of Examination, 17,720 candidates have been shortlisted for the next stage of scrutiny based on the normalized score and merit of candidates in the Computer Based Examination, in the following ratio:

- (a) 1:30 for vacancies up to 5 (subject to the availability of suitable candidates).
- (b) 1:15 subject to a minimum of 150 for vacancies more than 5 (subject to the availability of suitable candidates).
- (c) For vacancies reserved for PwBD / PwBD-Others / ESM candidates, all the PwBD / PwBD-Others / ESM candidates who are qualifying with minimum-cut-off criteria are to be shortlisted for scrutiny process.

6. Category-wise break-up of the candidates shortlisted in the Computer Based Examination for the next stage of scrutiny are as follows:

7. Post and Category wise cut-off details of candidates qualified against vacancies for **Matriculation Level** posts and number of candidates shortlisted, are given in **Annexure-I**.

8. The candidates **who are shortlisted for the next stage of scrutiny as per Annexure-I are required to upload self-attested copies of all the supporting documents** in respect of Educational Qualification (EQ), Experience, Category, Age, Age-relaxation, etc. (as applicable) from **11th February, 2026 (1100 Hrs)** till **03rd March, 2026 (2300 Hrs)** through online web portal **ONLY** by logging in with their credentials on the website of the Commission (<https://ssc.gov.in>). **The detailed flowchart/instructions for uploading the documents are given at ANNEXURE-II.** In case of any difficulty in uploading documents online, candidates may call **Toll Free Helpline Number - 1800 309 3063**. The candidates are informed that documents provided through any other mode **will not be accepted** for scrutiny purposes.

9. It may be noted that if a candidate has qualified for multiple categories of posts, then he/ she must upload the requisite documents separately for each category of post.

NOTE:- IF A CANDIDATE DOES NOT UPLOAD THE DOCUMENTS FOR ANY POST CATEGORY(IES), HIS/HER CANDIDATURE WILL NOT BE CONSIDERED IN FURTHER STAGES OF RECRUITMENT FOR SUCH POST CATEGORY(IES). IT MAY BE NOTED THAT AFTER 03rd MARCH, 2026 (2300 HRS), THE LINK FOR UPLOADING DOCUMENTS WILL BE DISABLED. NO REQUEST FOR ACCEPTING DOCUMENTS THROUGH ANY MODE WILL BE ENTERTAINED AFTER THE STIPULATED DATE.

10. For the Post Code CR11225 of the Matriculation Level, vacancies are reported only for Male candidates.

11. The result of candidates with the following Roll Numbers has been withheld due to various reasons. However, they are allowed to upload requisite documents regarding Eligibility, EQ, Experience etc. for the post codes given against their Roll Numbers in a separate list of Withheld Candidates. However, allowing them to upload documents will not bestow upon them any right to claim successful qualification in the examination.

14. Skill Test, wherever prescribed for any category of post(s) will be conducted from amongst the shortlisted candidates whose documents are received and found in order at Scrutiny stage by the User Department(s) / Regional Office(s) of the Commission. Due intimation in advance will be given by the respective Regional Offices to the candidates through their websites.

15. All qualified candidates found clear at the Scrutiny Stage for a particular category of post, will be called for Document Verification (DV) by the Regional Office / User Department to which the Post Category belongs. Accordingly, Admission Certificate for Document Verification will be issued by that Regional Office only.

16. As per Para 19.14 of the Notice of Examination, marks of the candidates will not be disclosed at this stage. The candidature of the shortlisted candidates is provisional.


